I **THOMAS BAILIFF** do make and publish this my last will and testament hereby revoking all former wills by me made.

- 1st. My will is that my funeral expenses and all of my just debts be paid out of the monies of which I may die possessed of or the first that shall come to the hands of my executor herein after named.
- 2nd. I will and bequeath to my daughter **ELIZABETH** and her heirs forever the sum of five dollars.
- 3rd. I give and bequeath to my daughter **REBECCA WILLY** and her heirs forever the sum of five dollars.
- 4th. I give and bequeath to my son **JOHN** and his heirs forever the sum of five dollars.
- 5th. I give and bequeath to my son **ROBERT** and his heirs forever the sum of five dollars.
- 6^{th} . I give and bequeath to my son **THOMAS** and his heirs forever the sum of five dollars.
- 7th. I give and bequeath to my granddaughter, daughter of my daughter **JANE** and her heirs forever the sum of five dollars.
- 8th. I give and bequeath to my daughter NANCY and her heirs forever the sum of five dollars.
- 9th. I give and bequeath to my beloved wife MARY during her natural life or widowhood all the balance of my personal estate together with the use and occupation of all my real estate. She shall have the right by will or otherwise to divide and give all the personal property and the proceeds whereof to my son SAMUEL and daughter MARY in such proportions and manner as she may choose, but in case she should marry then my will is that she take of my estate such portion as she would have done if I had died intestate and then the personal property given to her upon the contingency of her remaining my widow to be equally divided between my son SAMUEL and my daughter MARY equally except that part to which my wife will be entitled to by law.
- 10th. I give, bequeath and devise to my son **SAMUEL** and his heirs forever all of my real estate of which I may die died seized and possessed subject however to the life estate of my wife as before stated.
- 11th. I nominate and appoint my son **SAMUEL** to this my last will and testament given under my hand and seal the 17th day of October 1846.
