- 1. 1-Nov-1798 Robert Bailiff was born in Orange County, NC, the son of Thomas Bailiff and Elizabeth Baker. SOURCE: Bailiff Cemetery Headstone, Clark County, IL.
- 2. **31-May-1817 Robert Bailiff** purchased items at the estate sale of **John Baker** in Chatham County, NC. **SOURCE**: Estate Records of Chatham County, NC.
- 3. **23-Jan-1819** Edwin P. Bailiff, the first child of Robert and Anna Bailiff, was born in Chatham County, NC. **SOURCE:** Headstone, Lindley Cemetery, Crawford County, IL.
- 4. **27-Jun-1820** Thomas Bailiff, the second child of Robert and Anna Bailiff, was born in Christian County, Ky. **SOURCE:** Obituary of Thomas Bailiff, March 1891, Robinson Newspaper.
- 5. **1821** William Bailiff, the third child of Robert and Anna Bailiff, was born in Christian County, Ky. **SOURCE:** Death Certificate, Osage, Iowa.
- 6. **9-Oct-1823** Susan Jane Bailiff, fourth child of Robert and Anna Bailiff, was born in Christian County, Ky. SOURCE:
- 7. **1825** Andrew Bailiff, fifth child of Robert and Anna Bailiff, was born in Smith County, Tn. SOURCE: Smith County, Tn, Land Records, place Andrews Parents in Smith County, Tn, by 1825.
- 8. **2-Jan-1826 Robert Bailiff** paid one cent per acre at the office of the entry taker in Smith County, Tn, applying for a grant of 100 acres of land on the head waters of Bowling's Branch in Smith County, Tn. **SOURCE:** Bk 7, Page 405, Tn Land Grants, Tn State Library, Nashville, Tn.
- 9. **1-Jun-1827** Robert Bailiff received possession of land in Smith County, Tn, in grant 5934. This was the grant applied for in 1826. **SOURCE:** Bk 7, Page 405, Tn Land Grants.
- 10. **6-Nov-1829 Sarah Ann Bailiff**, sixth child of **Robert and Anna Bailiff**, was born in Smith County, Tn. **SOURCE:** 1860 Crawford County, IL, Census.
- 11. **1828-1830 Robert Bailiff**, Thomas Bailiff, Jesse Smith, John Bransford and David Davis are appointed to lay out the river road in Smith County. SOURCE: County Court Minutes 1828-1830, Page 277, Smith County, Tn.

- 12. **1830 Robert Bailiff** was an early minister who came from Caney Creek, Smith County, Tn, to Crawford County, IL, in 1830 in an ox cart and \$10 in his pocket. In 1831, he moved to Melrose Twp, Clark County, IL. **SOURCE**: 1883 History of Clark County, IL, Page 446.
- 13. **1830 Robert Bailiff** transfers 50 acres of land to **John B. Cate** in Smith County. **SOURCE:** County Court Minutes, Smith County, Tn, Page 37.
- 14. **1831** Nancy Caroline Bailiff, seventh child of Robert and Anna Bailiff, was born in Clark County, IL. **SOURCE:** 1883 History of Clark County, IL.
- 15. **6-21-1832** Robert Bailiff was the original purchaser of 40 acres of land in Clark County, Illinois, located in SW ¼ of SW ¼ of section 36. He paid \$1.25 per acre. **SOURCE:** Public Domain Land Sales Records For Illinois, Vol 291, Page 65, located in Illinois State Archives, Springfield, IL.
- 16. **7-16-1832** Robert Bailiff was the original purchaser of 40 acres of land in Clark County, Illinois, located in SE ¼ of SE ¼ of Section 35. - 17. **1833** The first services of the Bailiff Church were held at the cabin of **Robert Bailiff** by **Rev Silas Osborne. SOURCE:** 1883 History of Clark County, IL, Page 446.
- 18. **1834 Bailiff Church** was officially organized by **Rev Henry Groves** at **Robert Bailiff's** residence. The first members were **Robert Bailiff** and wife, **Joseph Green** and wife, **Sarah Buckner** and **Thomas Handy**. **SOURCE:** 1883 History of Clark County, IL, Page 446.
- 19. **28-Jan-1836 Robert B. Bailiff**, eighth child of Robert and Anna Bailiff, was born in Melrose Twp, Clark County, IL. **SOURCE**: 1860 and 1870 Clark County, IL, Census.
- 20. **28-Jan-1836 Anna D. Bailiff,** twin of **Robert B. Bailiff** and daughter of **Robert** and **Anna Bailiff**, was born in Melrose Twp, Clark County, IL. **SOURCE:** 1909 Crawford County, IL, History.
- 21. **8-Dec-1836** Robert Bailiff buys 10 acres in NW corner of E 1/2 of NE 1/4 of Section 2, Twp-8N. Range 12W, in Crawford County, IL, from William and Zelpha Hurst. **SOURCE:** Land Deeds, Crawford County, IL, Bk C, Page 358.
- 22. **1838 Robert Bailiff** was called as minister of Bailiff Cumberland Presbyterian Church in Melrose Twp, Clark County, IL, and served as minister until he died in 1877. This was a total of 39 years of ministry. The combined ministry of **Robert Bailiff**, his son **Thomas Bailiff** and his grandson **Thomas Chalkley Bailiff**, was
