

**REBECAH BAILIFF OF ORANGE COUNTY SOLD 100 ACRES ON WATERS OF
HENDERSON CREEK IN CHATHAM COUNTY NORTH CAROLINA TO THOMAS
CATE OF ORANGE COUNTY 1822**

This indenture made this **21st day of August in the year of our Lord one thousand eight hundred and twenty two.** Between **REBECAH BAILIFF** and **THOMAS CATE** both of the County of Orange and State of North Carolina. Witnesseth that the aforesaid **REBECAH BAILIFF** for and in consideration of the sum of one hundred dollars to her in hand paid the receipt whereof is hereby acknowledged hath granted bargained and by these presents doth grant bargain and sell alien and confirm unto him the said **THOMAS CATE** a certain tract or parcel of land lying and being in the County of Chatham and State aforesaid on the **WATERS OF HENDERSON CREEK** and bounded as follows. Beginning at **HAYSES CORNER** near the Fayetteville road running North with said **HAYSES LINE** forty nine poles to a hickory **CARTTOR WILKIN CORNER** thence West with his line one hundred and thirty six poles to a red oak thence South eighty nine poles to a post oak in **HENDERSONS OLD LINE** thence East with that line two hundred and thirty three poles to a post oak in **LUTTERLOH LINE** thence North with his line forty poles to a white oak in **HAYSES LINE** thence with that line to the first station **CONTAINING BY ESTIMATION ONE HUNDRED ACRES** the same more or less together with all and singular the appurtenances thereunto belonging or in any way appertaining. To have and to hold on and any part thereof unto him the aforesaid **THOMAS CATE** his heirs and assigns forever and I the aforesaid **REBECAH BAILIFF** doth her by bind myself and my heirs executors and administrators by these presents to warrant and defend the above bargained premises and every part thereof forever unto him the aforesaid **THOMAS CATE** his heirs and assigns forever. In witness whereof I have proceeded to set my hand, seal the day and year first above written.
