"1747. **THOMAS BAILIFF** [SR] is taxed in West Bradford Twp., Chester County, Pa." This is **THOMAS BAILIFF'S** first appearance in the tax records.

[We have to assume that **THOMAS** [SR] is single [FREEMAN] in 1747 since he is not listed as married.]

PROJECTED AGE: Born 1726

ESTIMATED ARRIVAL IN CHESTER COUNTY: 1738 or 1739

Terms used in tax records.

FREEMAN: Single and at least 21 years of age. [This means **THOMAS BAILIFF** [**SR**] was born 1726].

INMATE: Married or widowed and landless. [This means a person is either married or widowed. A widowed person is never listed as single. If the person owned land it would say "Land".]

SUMMARY OF THOMAS BAILIFF'S AGE ESTIMATE

- 1. **THOMAS BAILIFF** [**SR**] born 1726 in Dublin, Ireland.
- 2. **THOMAS BAILIFF** [SR] is living in the home of his brother until 1747.

No BAILIFF'S appear in Chester County, Pa.

3. THOMAS BAILIFF [SR] name evolved from BAYLY to BAYLIFF to BAILIFF.

	wife died during this time period.
1762-1768	THOMAS BAILIFF [SR] is not in Chester County, Pa, during this time period.
	[Found in Orange County, NC, county board minutes listed as serving on a Grand
	Jury 1765.]
1769	THOMAS BAILIFF [SR] inmate taxed in Newlin Twp. [Appears his brother
	EDWARD is ill and died Dec. 1769 without any known descendants]
	[THOMAS [SR] is married and wife is named Rebecca.]
1770	THOMAS [SR] is not on the tax list but in this year is appointed as administrator
	of his brother's estate. THOMAS [SR] receives the entire estate of
	EDWARD'S in Newlin Twp.
1771-1778	THOMAS BAILIFF [SR] inmate taxed West Bradford Twp.
1778	THOMAS BAILIFF [SR] name is first written on tax list THEN CROSSED
	OFF suggesting he left the county in this year.

1784-1785 THOMAS [SR] inmate taxed in East Bradford Twp. [It appears THOMAS BAILIFF [SR] died on the trip back to Orange County, NC, in early 1785.]

REBECCA BAILIFF buys land for sons THOMAS BAILIFF [JR] and ABNER BAILIFF in Orange County, North Carolina.
